OPINION STUDY IN SERVICE OF FINANCE AND PROCUREMENT FACULTY OF SCIENCE AND TECHNOLOGY, SUAN SUNANDHA RAJABHAT UNIVERSITY

ABSTRACT

This research aims to study about staff's opinion study in service of finance and procurement Faculty of Science and Technology, Suan Sunandha Rajabhat University and compare staff's opinion in overall, personnel aspect, service process aspect and facilities aspect. The sample was 107 official staff in Faculty of Science and technology by simple random sampling. The questionnaires were used to collect data and analyze by mean and standard deviation, independent t-test and ANOVA.

The results showed that the official staff, most were academic staff and were female, with 7-9 years of experiences, in addition, the level of staff's opinion both overall and each aspects (facilities aspect, personnel aspect and service process aspect.) were in the highest level. The comparison of staff's opinion in overall, personnel aspect, service process aspect and facilities aspect. Were no significant differences at .05 levels.

1. INTRODUCTION

The office of the Faculty of Science and Technology, Suan Sunandha Rajabhat University. The finance and procurement department the most important unit in the faculty. The Ministry of Finance is the agency responsible for setting rules, regulations, rules, regulations, procedures for disbursement of government agencies. The Ministry of Finance has a system for monitoring and controlling the disbursement of government agencies. Use financial data for analysis Suggestions for senior executives of ministers and other policy-setting agencies. The Faculty of Science and Technology has been allocated the budget for learning and teaching and providing various academic services. The faculty's disbursement process consists of finance and supplies unit responsible for the entire faculty's disbursement. Therefore, the researchers were interested in studying the opinion study in service of finance and procurement Faculty of Science and Technology, Suan Sunandha Rajabhat University in order to be aware of the real needs and points of improvement for the service.

2. OBJECTIVES

1) To study the staff's opinion study in service of finance and procurement Faculty of Science and Technology, Suan Sunandha Rajabhat University.

2) To compare staff's opinion in overall, personnel aspect, service process aspect and facilities aspect.

3. METHODOLOGY

Population: 146 faculty members and staff of the Faculty of Science and Technology, Suan Sunandha Rajabhat University.

Sample: randomly 107 faculty members and staff of the Faculty of Science and Technology by using calculating sample size method of **Taro Yamane**. [5]

Tool: Questionnaire on the staff's opinion study in service of finance and procurement Faculty of Science and Technology, Suan Sunandha Rajabhat University.

4. DATA ANALYSIS

The questionnaires were analyzed statistically using computer statistical software packages to calculate the statistics. Descriptive statistics were used to explain personal factors of the staff's opinion study in service of finance and procurement Faculty of Science and Technology, Suan Sunandha Rajabhat University using mean and standard deviation to explain the opinion level study in service of finance and procurement Faculty of Science and Technology, Suan Sunandha Rajabhat University and using Inferential Statistics in addition, independent t-test and analysis of variance (ANOVA) were used for comparing the staff's opinion in overall, personnel aspect, service process aspect and facilities aspect.

5. RESULTS

The results of the staff's opinion study in service of finance and procurement Faculty of Science and Technology, Suan Sunandha Rajabhat University are as follow:

($\bar{x} = 4.561$, S.D. = 0.517) are in the highest level opinion, respectively.

The analysis of variance (ANOVA) was used for analyzing. It was found that the overall and each aspect as personnel aspect, Service process aspect and facilities aspect on significant differences at .05 levels with p-value as .243, .545, .285 and .388, respectively.

6. CONCLUSION

This research emphasizes the key issue of the results in the opinion study in the service of Finance and Procurement Department of Faculty of Science and Technology, Suan Sunandha Rajabhat University. The staff's opinion in personnel aspects found that the highest level and matching research found that the factors affecting the service are having enthusiasm for management Fast Service Voluntary and willing to serve the gentle manner, polite, smiling and service quality of work personnel [6]. Service process aspect found that the highest level and matching research found that material, equipment, and technology of adequacy. Support the operation of the financial department's in the efficiency of service [7] and facilities aspect found that the highest level and consistent with the Maslow's Hierarchy of need found that Maslow stated that our most basic need is for physical survival once that level is fulfilled the next level up is what motivates us, and so on divides into 5 categories: 1) Physiological needs, 2) Security or safety needs, 3) Social or belongings needs, 4) Esteem or status needs, and 5) Self-actualization or self-realization respectively [8]. The results comparison of staff's opinion in overall by service recipients and job position found that opinion level is no different statistically significant. The results of the study do not match the concept [9]. Defining opinions means the feelings or gestures of the person expressing the facts. And attitudes towards individuals, things or places that can be expressed in a positive or negative way and communication etc.
