The global cannabis market value is expected to continue to grow. or equivalent to a value of more than US \$ 103.9 billion in 2024, divided into the medical cannabis market, accounting for approximately 60 percent of the total cannabis market value, and the other 40 percent of the recreational cannabis market. Interested in using hemp extract as ingredients in the product affect long-term trends The value of the global cannabis market will grow and more spread out in many businesses (Kasikorn Research Center, 2020) for Thailand Despite the promulgation of the first Cannabis control law since Year 2477, but the said law. It is also specified that it can be used for the benefit of any disease. Subsequently, after Thailand became a party to the Convention of the Organization The United Nations has therefore repealed the original Cannabis law. in the promulgation The Narcotics Act of 1979 that legalizes Cannabis as a narcotic. Type 5 makes the use of Cannabis in Thailand illegal (Weeraya Thaupachit, 2019). However, with the medical value of Cannabis, people still use it secretly. Although there is a risk of harm from using Cannabis that is of poor quality or contaminated with Poison (1) and also causes a hindrance In a study on the benefits of Cannabis in Medicine has been made in the past 20-30 years in many countries. has improved the law to work around these limitations. Access to the safe use of medicinal cannabis and herbs to create official opportunities Maintaining the economy and generating income for the people, the Ministry of Public Health has therefore accelerated operations. so that people across the country can access free medical Cannabis services thoroughly by In August 2019, Cannabis clinics were opened in pilot hospitals in 12 health districts, with 12 modern medical Cannabis services open and Thai traditional and alternative medicine, 7 locations, totaling 19 locations, and later expanded The service area has increased accordingly. At the end of the year 2019 has been ordered to open for service, medical Cannabis in affiliated hospitals covering all provinces across the country In part of Chiang Mai province, there are Number of liberal medical Cannabis clinics 37 places According to the service expansion plan in Phase 4 However The number of people who have access to medical Cannabis services in cannabis clinics has not increased as much as it should have. Many medicinal cannabis are not prescribed (Department of Medicine, 2021). Therefore, it is necessary to understand the problem and find solutions in development to drive the implementation of this policy to achieve the goals and Public and private management approaches affecting the liberalization of medical Cannabis policy alternatives and lead to tangible results Meet the needs of the people drive the plan


Definitions of terms
